### RESOLUTION NO. 149

#### EXPRESSING STRONG OPPOSITION TO THE PROPOSED REPRODUCTIVE HEALTH BILL IN CONGRESS, REPUBLIC OF THE PHILIPPINES

WHEREAS, the said bill aims to promote and spread contraception or artificial birth control which is against our religious upbringing being the only Christian country in Asia;

WHEREAS, the principles of the said bill do not respect the purpose of conjugal act that is an expression of love between husband and wife and the procreation of children;

WHEREAS, contrasting to such bill is tantamount to opposing to injustice, oppression, casinos, drugs, pollution, illegal logging or graft and corruption which constitute to the growing incident of criminality in our country;

WHEREAS, approving the bill would run afoul to the constitutional mandate for the state to equally protect the life of the mother and the life of the unborn from conception as provided by Sec. 12 article 2 of 1987 constitutions;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal duly assembled in session, hereby expresses strong opposition to the proposed Reproductive Health Bill in Congress, Republic of the Philippines;

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.


