**AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE
GEORGE RICARDO R. GACULA II, TO NEGOTIATE AND ENTER
INTO A MEMORANDUM OF AGREEMENT WITH LITUS
SOFTWARE INCORPORATED FOR THE COMPUTERIZATION
PROJECT OF THE POLICE STATION**

WHEREAS, Litus Software Incorporated is an Information Technology Firm which specializes in designing software primarily to aid PNP officials to speed up operations in its crime fighting efforts and enhance modernization of management in the police force;

WHEREAS, the company is offering their services to the different PNP stations in the Province of Rizal with no direct investment to the local

government except that the public will be charged a minimal fee of P100.00 for every issuance of police clearance;

WHEREAS, the system will allow the Taytay Police Station to computerize the issuance of police clearance and maintenance of records and provide a more efficient management system without any expense on the part of the local government unit;

WHEREAS, the Sangguniang Bayan of Taytay deemed it advantageous to the municipality to accept the offer of Litus Software Incorporated;

NOW THEREFORE BE IT RESOLVED, as it is hereby resolved, the Sanggunian Bayan duly assembled in session hereby authorizes the Municipal Mayor Hon. George Ricardo R. Gacula II, to negotiate and enter into a Memorandum of Agreement with Litus Software Incorporated for the computerization project of the Police Station;
