**REQUESTING ALL BUSINESS AND/OR COMMERCIAL
ESTABLISHMENT OPERATING WITHIN THIS MUNICIPALITY
AND WITH A CAPITAL BASE OF (PHP 200,000.00) TWO
HUNDRED THOUSAND PESOS OR ABOVE, TO SECURE A
PUBLIC LEGAL LIABILITY INSURANCE**

WHEREAS, the General Welfare Clause of R.A. 7160, otherwise known as the Local Government Code of 1991 specifically invested every Local Government Unit to preserve the comfort and convenience of their inhabitants and to further promote the general welfare of the public;

WHEREAS, bodily harm or injuries and/or damage to properties may occur, either by accident or negligence in maintaining and/or operating business/commercial establishments.

WHEREAS, as measure of preserving public safety, and to avoid the cumbersome process of pursuing indemnities against the owners or proprietors of the business and/or commercial establishments, who in the course of its operation or pursuit of its business undertaking and/or activities, causes injuries to any person or damage to properties, the Sangguniang deems it sound to require these establishments to secure public legal liability insurance.

NOW THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Bayan in session duly assembled hereby requests all business and/or commercial establishment operating within this municipality and with a capital base of (Php 200,000.00) Two Hundred Thousand Pesos or above to secure a Public Legal Liability Insurance.


RESOLVED FURTHER, that copy of this Resolution be furnished to all concerned for their information and appropriate action.
