REPRESENTED BY HON. GEORGE RICARDO R. GACULA II AND
SPS. FLORENCIO R. PADUA AND IRMA REYES PADUA FOR THE
PROPOSED EXTENSION OF TAYTAY PUBLIC CEMETERY,
LOCATED AT KAY BURAL, BARANGAY SAN JUAN, TAYTAY,
RIZAL**

WHEREAS, as per Resolution No. 113 series of 2008 the Sangguniang Bayan gave authority to the Municipal Mayor Hon. George Ricardo R. Gacula II to negotiate with Florencio Padua and Irma Reyes Padua for the purchase of their property for the proposed extension of Taytay Public Cemetery, located at Kay Bural, Barangay San Juan, Taytay, Rizal;

WHEREAS, in the pursuit of progress and development, the Local Government Unit has planned to expand Taytay Public Cemetery;
