RESOLUTION NO. 22

**AUTHORIZING HON. GEORGE RICARDO R. GACULA II, MUNICIPAL
MAYOR TO ENTER TO NEGOTIATION AND MEMORANDUM OF
AGREEMENT FOR THE PRIVATIZATION OF GARBAGE COLLECTION BY
ENGAGING THE SERVICES OF QUALIFIED CONTRACTOR OR
CONTRACTORS TO UNDERTAKE THE COLLECTION, HAULING AND
DISPOSAL OF SOLID WASTE IN THE MUNICIPALITY OF TAYTAY, RIZAL
AND FOR OTHER PURPOSES**

WHEREAS, the provision for solid waste disposal is one of the basic services that the municipality is mandated to provide its inhabitants under the provisions of R.A. 7160;

WHEREAS, the law recognizes the importance and allows private participation in the delivery of basic services by local government units as provided in Article 30 of the Rules and Regulations Implementing the Local Government Code of 1991:

*"Art. 30 Commercialization and Privatization. - x x x
(b) Without prejudice to the social attributes of basic services and facilities,
LGU's may tap the private sector in the delivery of basic services and facilities;*

" (c) Reasonable cost may be charged by the private sector concerned for the operation and management of economic enterprises for the delivery of basic services and facilities; x x x. "

WHEREAS, with the end in view of improving the efficiency of garbage collection in a cost effective manner, the Municipal Mayor recommended the privatization of garbage collection, hauling and its disposal to any regulated and accredited dumpsite;

WHEREAS, the propose privatization shall include the management and operation of centralized Material Recovery Facility of the municipality;

WHEREAS, that the MOA shall be ratified by the Sangguniang Bayan before its full implementation;

NOW THEREFORE, after due deliberation, on motion duly seconded, it was resolved, as it is hereby resolved, to authorize Hon. George Ricardo R. Gacula II to negotiate and enter to memorandum of agreement (MOA) for the privatization of garbage collection through partial participation to undertake the collection, hauling and disposal of solid waste in the Municipality of Taytay, Rizal subject to the following:

1. That the construction, management and operation of the transfer station and material recovery facility shall be included in the privatization;
2. That the selection of contractor shall be determined by competitive public bidding among qualified contractors;
3. That the respective duties, functions, obligations and responsibilities of the contractor and the municipality be clearly defined in the subsequent contract which shall be entered into for the purpose.

RESOLVED FINALLY, that the Municipal Mayor be as he is hereby authorized to execute the necessary contract for and in behalf of the municipality and the copies of the resolution be furnished to all concerned and for their appropriate action.

ADOPTED, this 5th day of February 2009, at the Session Hall of Municipal Building, Taytay, Rizal.
