**REQUIRING ALL FINANCIAL INSTITUTIONS IN THE
MUNICIPALITY OF TAYTAY TO INSTALL A CLOSED-
CIRCUIT TELEVISION SYSTEM (CCTV) WITHIN
THEIR PREMISES**

WHEREAS, subject to the provision of Local Government Code of 1991, every Local Government Unit shall promote the general welfare and safety of the public;

WHEREAS, Closed-Circuit Television System (CCTV) is an instrument used for general surveillance purposes in areas that may need monitoring and had become a means of increasing security in banks and other financial institutions;

WHEREAS, in the desire of Municipal Government of Taytay to have effective public service, it is of utmost significance to require the installation of Closed-Circuit Television System (CCTV) in all financial institutions within the Municipality of Taytay to protect its clients and discourage theft;

NOW THEREFORE BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal duly assembled in session, hereby requires all financial institutions in the Municipality of Taytay to install a Closed-Circuit Television System (CCTV) within their premises;


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action;
