WHEREAS, the Municipal Government had already accommodate the different offices of National Agencies for the benefit of the constituents and the community, thus developing the town as a center for the National Agencies in Rizal Province;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action;


