RESOLUTION NO. 62

**AUTHORIZING THE MUNICIPAL MAYOR HON. GEORGE
RICARDO R. GACULA II TO NEGOTIATE AND ENTER INTO A
MEMORANDUM OF AGREEMENT (MOA) WITH THE
DEPARTMENT OF EDUCATION RELATIVE TO THE OPERATION
AND MAINTENANCE OF “SIMONA NATIONAL HIGH SCHOOL”,
A PUBLIC SECONDARY SCHOOL AT SIMONA SUBDIVISION,
BARANGAY SAN ISIDRO, TAYTAY, RIZAL**

WHEREAS, it is barely three (3) days to go before the formal opening of classes on Monday, June 01, 2009, however, parents of Grade VI graduates from Simona Elementary School are still in great distress and worrying too much because the Simona National High School has not formally opened yet, contrary to everybody's expectations;

WHEREAS, quite a big number of newly-graduated elementary students from schools mentioned above whose names belong to the enrollees of the new public high school will be deprived of the convenience of enrolling and studying in FREE public secondary education in the area very near their home;

WHEREAS, in this time of economic crisis or *hard times*, to enroll and study in schools far from their home would surely entail extra-time, extra-effort and extra-cost of expenses, a sad plight which is too hard for the concerned parents to bear nowadays, hence, their plea to the Sangguniang Bayan to address the problem with outmost urgency;

WHEREAS, the August Body sees this necessity for our Chief Executive to be authorized to negotiate and enter into a Memorandum of Agreement (MOA) with the Department of Education for the possibility of Simona National High School to open and operate this coming June 2009 school year;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal assembled in session, hereby authorizes the Municipal Mayor Hon. George Ricardo R. Gacula II to negotiate and enter into a Memorandum of Agreement (MOA) with the Department of Education relative to the operation and maintenance of the new SIMONA NATIONAL HIGH SCHOOL, a public secondary school at Simona Subdivision, Barangay San Isidro, Taytay, Rizal.


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
