WHEREAS, Constancio Valletero et al is the registered owner two parcel of land situated at Velasquez Street Brgy. San Juan Taytay, Rizal consisting of 548 square meters covered by Tax Declaration No. 00-TY-004-10730 and another 104 square meters covered by Tax Declaration No. 00-TY -004-10727;

NOW THEREFORE RESOLVED, as it is hereby resolved, the Sangguniang Bayan in session duly assembled hereby accepts the Deed of Donation executed by Concordia Valletero, Maxima Valletero and Constancio Valletero et al to the Municipal Government of Taytay thru Municipal Mayor Hon. RESOLVED FURTHER, that copies of this Resolution be furnish to all concerned for their information and appropriate action.


