**REQUESTING OUR MUNICIPAL HEALTH OFFICE TO CONDUCT
A THERMAL OR TEMPERATURE SCANNING TO ALL
EMPLOYEES AND VISITORS BEFORE ENTERING THE NEW
TAYTAY MUNICIPAL BUILDING, AS WELL AS ON PUBLIC
SCHOOLS AND OTHER GOVERNMENT OFFICES IN THE
LOCALITY**

WHEREAS, the health and safety of all municipal employees and visitors entering the new Taytay Municipal Building should be guarded in as much as there is rapid increase of the A (H1N1) virus almost everywhere;

WHEREAS, the new and old Taytay Municipal Building as well as public schools should be kept free from the plaguing virus;

WHEREAS, the Sangguniang Bayan as manifestation of its desire to contribute much to protect our own employees and visitors as well as to prevent the spread of the virus to others, shall provide, first and foremost, precautionary measures specifically by use of thermal scanners or infrared thermometers;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved the Sangguniang Bayan duly assembled in session hereby request our Municipal Health Office to conduct a Thermal or Temperature Scanning to all Employees and Visitors before entering the new Taytay Municipal Building, as well as on Public Schools and other Government Offices in the locality;

RESOLVED FURTHER, that the private establishment & private schools be encouraged to do their own similar or related preventive acts and/or measures against the spread of A (H1N1) virus;

RESOLVED FURTHERMORE, the copies of this resolution be furnished to all concerned for their information and appropriate action.


