THEIR HEAVY EQUIPMENT TO HELP IN OUR EFFORT TO
SOLVE THE PERENNIAL FLOOD PROBLEM IN TAYTAY, RIZAL**

WHEREAS, the Municipality of Taytay serves as a catch basin after continuous heavy downpour;

WHEREAS, flood cause persistence of communicable diseases that may also resort to loss of lives and likewise, destruction of roads bridges and other properties;

WHEREAS, progress and development of the town are adversely affected by frequent and widespread floodings;

WHEREAS, the municipality, in absence of its own effective and more appropriate heavy equipment being used during large-scale river dredging and clearing operations like long-arm back hoes, barges, vacuum trucks, etc...considered requesting to the Office of the MMDA thru its Chairman for the temporary use of their highly efficient heavy-equipment for the town's flood control and mitigating efforts;

NOW THEREFORE, BE IT RESOLVED, as it is being resolved, that the Sangguniang Bayan hereby approve requesting Chairman Bayani Fernando for the use of their heavy equipment to help in our effort to solve the perennial flood problem of the municipality;
