**RECOMMENDING TO THE EXECUTIVE DEPARTMENT
TO PRIORITIZE THE FUNDING OF THE PROPOSED
MATERIALS TO BE USED FOR THE INSTALLATION
OF STREETLIGHT POSTS LOCATED AT HAPAY NA
MANGGA, BARANGAY DOLORES, TAYTAY, RIZAL
AMOUNTING TO ELEVEN THOUSAND ONE HUNDRED
TWENTY ONE PESOS (PHP 11,121.00) AND TO BE
CHARGERD UNDER THE BAYANIHAN FUND**

WHEREAS, one of the primary objectives of our local government is to serve the needs of our municipality;

WHEREAS, the residents of Hapay na Mangga has requested for the installation of streetlights posts in their area;

WHEREAS, Sitio Hapay na Mangga creekside needs streetlights for the area to be safe and accessible to its residents;

WHEREAS, in approving the installation of streetlight application, at Sitio Hapay na Mangga creekside a streetlights posts had to be constructed first;

WHEREAS, our Engineering Department through Engr. Ronald San Juan have submitted the program of works for the project;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan duly assembled in session hereby recommends to the Executive Department to prioritize the funding of the proposed materials to be used for the installation of streetlight posts located at Hapay na Mangga, Barangay Dolores, Taytay, Rizal amounting to Eleven Thousand One Hundred Twenty One Pesos (Php 11,121.00) and to be charged under the Bayanihan Fund;

RESOLVED FURTHER, that copy of this resolution be furnished to all concerned for their information and appropriate action;

ADOPTED, this 20th day of August 2009 at the Session Hall of the Municipal Building, Taytay, Rizal.


