**RECOMMENDING TO THE MUNICIPAL DEVELOPMENT
COUNCIL TO PRIORITIZE THE FUNDING FOR THE
CONSTRUCTION OF DAY CARE CENTER LOCATED
AT PUROK 6, BARANGAY STA. ANA, TAYTAY, RIZAL
AMOUNTING TO SEVEN HUNDRED FIFTY THOUSAND
PESOS (PHP 750,000.00) AND TO BE CHARGE UNDER
THE DEVELOPMENT FUND**

WHEREAS, ARNAI Day Care Center is already an established day care center supervised by our Municipal Social Welfare Development (MSWD) located at Barangay Sta. Ana, Taytay, Rizal;


WHEREAS, the residents of Purok 6, Barangay Sta. Ana have requested for the renovation of the existing Day Care Center to accommodate the increasing population of students and for them to have a good learning environment;

WHEREAS, our Engineering Department through Engr. Ronald San Juan have submitted the program of works, that instead of renovation, the existing Day Care Center should be demolished first and build a new center,


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan duly assembled in session hereby recommends to the Municipal Development Council to prioritize the funding for the construction of Day Care Center located at Purok 6, Barangay Sta. ana, Taytay, Rizal amounting to Seven Hundred Fifty Thousand Pesos (Php 750,000.00) and to be charged under the Development Fund;

ADOPTED, this 20th day of August 2009 at the Session Hall of the Municipal Building, Taytay, Rizal.


