**REQUESTING SECRETARY ARTURO YAP OF THE
DEPARTMENT OF AGRICULTURE FOR AN IMMEDIATE
POSSIBLE ASSISTANCE REGARDING THE DAMAGES
INCURRED CAUSED BY TYPHOON ONDOY TO OUR FARMERS
AND FISHERMEN**

WHEREAS, last September 26, 2009, Typhoon "Ondoy" has unleashed its strength that severely flooded the whole of Metro Manila and the nearby provinces;

WHEREAS, the calamity has grossly affected our agricultural sector wherein 168 hectares of rice field, 102 hectares of "kangkungan" and 2 hectares of fish ponds were inundated;

WHEREAS, delivery of basic social services must be the paramount concern of the administration;

WHEREAS, to sustain this pressing needs of the constituents in this times of crisis, the Sangguniang Bayan is duly bound to mitigate the disastrous effect of typhoon to the above mentioned sectors;

WHEREAS, this resolution is in response to the occurrence of above mentioned typhoon which have caused severed damages to the country and brought severe flooding to our municipality;

NOW THEREFORE BE IT RESOLVED, as it is hereby resolved, the Sangguniang Bayan in session hereby requests Secretary Arturo Yap of the Department of Agriculture for an immediate possible assistance regarding the damages incurred caused by Typhoon "Ondoy" to our farmers and fishermen;
