JUCUTAN, CHIEF-HIGHWAY PATROL GROUP 4-A RIZAL FOR THE PROPOSED CONSTRUCTION OF OFFICE IN THE LOCALITY PARTICULARLY IN YNARES ECO-SYSTEM AREA, BARANGAY SAN JUAN, THIS MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL
