TO INCLUDE IN HIS PRIORITY FOR INFRASTRUCTURE
PROJECT, THE ASPHALT OVERLAY OF ROAD ALONG
NEW TAYTAY PUBLIC MARKET CONNECTING TO THE
HI-WAY 2000 (PHASE I)**

WHEREAS, there is a significance to the development of road along New Taytay Public Market that connects Highway 2000, since it has become an alternative route by motorist in going to and coming from metropolis;

WHEREAS, the unbearable road condition at New Taytay Public Market traversing the Hi-way 2000, which at present, was filled with too many path holes causes slowing down the movement of vehicles, thus making much discomfort to motorists passing thereat, must be remedied so as to enhance further the flow of trade and commerce in the area;

WHEREAS, desirous of having not only good road network but also to promote the comfort and convenience of its constituents and the public at large, the Sangguniang Bayan of Taytay, Rizal deemed it sound to seek an aid from offices and authorities that possess the means and resources to act with dispatch;

ADOPTED, this 10th day of December, 2009 at the Session Hall of the Municipal Building, Taytay, Rizal.


