RESOLUTION NO. 192

AUTHORIZING THE MUNICIPAL MAYOR, HON. GEORGE RICARDO R. GACULA II, TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT UNDER A BUILT-OPERATE AND TRANSFER SCHEME (BOT) FOR THE MUNICIPAL SLAUGHTERHOUSE

WHEREAS, the Philippines Abattoir Development Master Plan underscores that almost 80% of abattoirs operating in the country is owned and operated by the Local Government Units (LGU's), of which 90% failed to comply with the standard design, construction and installation of equipment;

WHEREAS, at present the Municipal Government of Taytay operates its Municipal Slaughterhouse or locally registered Meat Establishment and categorized as single "A";

WHEREAS, the Municipality of Taytay with a population of almost 350,000 and grows from 5-8% annually requires the supply of meat equivalent to 500 heads of hogs or 35 tons of meat daily, thus to be fully protected from ingesting diseased or contaminated meat;

WHEREAS, there is a need to rehabilitate/construct our existing Municipal Slaughterhouse to make abattoirs operation and maintenance viable;

WHEREAS, on a BOT scheme, the proponent will put up a modular design which will rehabilitate the existing municipal abattoirs, upgrade its facilities to conform with NMIS (National Inspection Service) standard and eventually pass and be categorized as double "AA" wherein all slaughtered meat can be transported to any part of the country;

NOW THEREFORE, be it resolved, as it is hereby resolved, by the Sangguniang Bayan in session duly assembled hereby authorizes the Municipal Mayor Hon. George Ricardo R. Gacula II, to negotiate and enter into a Memorandum of Agreement under a Built-Operate and Transfer (BOT) scheme for the Municipal Slaughterhouse;

RESOLVED FURTHER, that copies of this Resolution be furnished to all concern for their information and appropriate action.

ADOPTED, this 17th day of December, 2009 at the Session Hall of the Municipal Building, Taytay, Rizal.
