WHEREAS, the said project will provide an immediate source of income to the beneficiaries and their families in the locality ;


WHEREAS, the Sangguniang Bayan Committee on Labor & Employment shall served as an overseen for the implementation of the said project;

ADOPTED, this 7<sup>th</sup> day of January 2010, at the Session Hall of the Municipal Building of Taytay, Rizal.


