RESOLUTION NO. 2

OPPOSING THE PROPOSED REVOCATION OF PRESIDENTIAL PROCLAMATION # 704 AND APPEALING TO DEFER THE SIGNING PRIOR TO RE- EVALUATION AND CONSULTATION AMONG STAKEHOLDERS

WHEREAS, there is Presidential Proclamation # 704 dated November 28, 1995 which reserves a portion of the public domain located at Sitio Tapayan Barangay Sta. Ana, Municipality of Taytay, Province of Rizal; Transferring to the National Housing Authority the ownership of said government land and declaring the same open for disposition in favor of Pasig River squatters and less privileged families of the municipality, pursuant to Public Act No. 7279, otherwise known as "Urban Development and Housing Act of 1992 and Executive Order No. 292, otherwise known as Administrative Code of 1987",

WHEREAS, investment, materials wise coupled with spirituality and social attributes had been made by the settlers to built a community they now consider HOME following the rule of heaven and earth to bind the inhabitants with LOVE, UNITY and PEACE;

WHEREAS, last month of September the country was severally hit and affected by typhoons ONDOY and PEPENG" inundating many parts of Luzon, more particularly the cities and towns of Marikina, Pasig, Cainta and Taytay, Rizal;

WHEREAS, the National Government was made to believe that the preserve of Lupang Arenda community at Barangay Sta. Ana this Municipality causes the severe and prolonged floodings, to wit:

1. *A letter from Vice-President Noli De Castro to Hon. Jose L. Atienza, Jr DENR Sec. dated November 2009 in reference to the instruction to HUDCC to prepare and submit a draft revoking Proclamation # 704, to conduct the necessary evaluation and prepare and investigation report as part of the process of completed staff work.*
2. *The immediate response of the DENR Office through the report dated November 25, 2009 together with the complete staff work.*

WHEREAS, however the residents Lupang Arenda and many more others strongly believed otherwise, the community had been developed and fast moving toward progress notwithstanding the effort, sweat, tears and money contributed altogether. Therefore, they need the strong support of the government officials whom they completely trust to carry on toward the realization of their mission and vision;

WHEREAS, revocation of Presidential Proclamation #704 will be a cruel step to destroy the strong bond which naturally will be regarded as inhuman by the public;

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Bayan in session hereby opposes the proposed revocation of Presidential Proclamation #704 and appealing to defer the signing prior to re-evaluation and consultation among stakeholders;


RESOLVED FURTHER, that copies of this Resolution be furnish to all concerned for their information and appropriate action.

PINAGTIBAY PA, na padalhan ng sipi ang lahat ng kinaukulan para sa kanilang kaalaman.


