WHEREAS, the Sangguniang Bayan of Taytay find it necessary to grant Honorarium/Allowance/Uniforms to each member of the Taytay Municipal Choir at a rate of P60.00 per practice and P100.00 per performance representation on local affairs, for the Chorale Trainer at the rate of P350.00 per practice and performance;

WHEREAS, the granting of honorarium/allowance/uniforms for twenty nine (29) members in the amount of Six Hundred Seventy Four Thousand Pesos Only (P674,000.00) from the period of January to December 2010 is in conformity with the rules and regulations of the Commission on Audit and our Municipal Budget Office;




RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action;

ADOPTED, this 18th day of March 2010, at the Session Hall of the Municipal Building, Taytay, Rizal.


