### RESOLUTION NO. 39

**APPEALING TO HIS EXCELENCY BENIGNO S. AQUINO III, PRESIDENT  
OF THE REPUBLIC OF THE PHILIPPINES TO CONSIDER DEFERRING THE  
IMPLEMENTATION OF EXECUTIVE ORDER NO. 854 PRIOR TO THE RE-  
EVALUATION AND PROPER CONSULTATION AMONG STAKEHOLDERS**

WHEREAS, the Executive Order No. 854 Revoking Proclamation No. 704, s. 1995 and Proclamation No. 1160, s. 2006; Establishing a task force to formulate and implement a comprehensive rehabilitation plan for Napindan Channel, Lupang Arenda and Manggahan was signed by President Gloria Macapagal-Arroyo last December 4, 2009;

WHEREAS, the copies of the said Executive Order No. 854 was not properly disseminated to people concerned especially those living within the said areas affected by the Executive Order 854 and the Local Government Unit of Taytay which was mentioned as member of the created Technical Working Group of the EO 854;

WHEREAS, the residents of Lupang Arenda and many more others strongly believed that the recommendation to revoke the mentioned proclamations in the EO 854 was based on inaccurate information and lack of comprehensive studies;

WHEREAS, the created Technical Working Group who said that they have made some series of consultations, schedules and census among concerned people has not actually done before the signing of the said EO 854 by President Her Excellency Gloria Macapagal Arroyo, while said procedures is part of the documentation of establishing an Executive Order;

WHEREAS, the Sanggunian Bayan of Taytay had approved Resolution 35, series of 2010 opposing the implementation and submitted same to the Office of the President last May 20, 2010;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, the Sangguniang Bayan in session duly assembled hereby appeals to HIS EXCELLENCY BENIGNO S. AQUINO III, President of the Republic of the Philippines to consider deferring the implementation of Executive Order No. 854 prior to the re-evaluation and proper consultation among stakeholders.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.

ADOPTED, this 10<sup>th</sup> day of June 2010, at the Session Hall of the Municipal Building, Taytay, Rizal.


