RESOLUTION NO. 47

GRANTING FINANCIAL ASSISTANCE TO THE VICTIM OF FIRE THAT DESTROYED THE NEW TAYTAY PUBLIC MARKET LAST MAY 27, 2010 AND THE AMOUNT NEEDED FOR THE PURPOSE SHALL BE TAKEN FROM THE CALAMITY FUND CY 2010

WHEREAS, last May 27, 2010, a fire of unknown origin broke at New Taytay Public Market, this municipality, reducing to ashes wares and stocks in trade of businessmen therein;

WHEREAS, R.A. 7160, otherwise known as the Local Government Code of 1991, specifically empowered the Sangguniang Bayan to extend relief services by providing in its Section 447, par. A. sub. Par. 1.[iv] as follows;

xxxx Adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disaster or calamities and in their return to productive livelihood following said events; xxxx

WHEREAS, as we endeavor to encourage capital investment, particularly the setting up of small and medium business enterprises, support must be accorded to, and felt by those who have lost in their investment as a result of this unfortunate event;


WHEREAS, it is indeed necessary for the Sangguniang Bayan to devise a means, that will provide assistance, and to enable our businessmen affected thereat to recover the least of their capital losses and to normalize their business activities;

NOW THEREFORE, be it resolved, as it is by resolved, by the Sangguniang Bayan, in session duly assembled, hereby grants financial assistance to the victims of fire that destroyed New Taytay Public Market, last May 27, 2010, and the amount needed for the purpose shall be taken from the Calamity Fund CY 2010.

RESOLVED FURTHER, that copies of this resolution be furnished to the victims affected thereat and concern offices of this municipality for information, guidance and reference purposes.

ADOPTED, this 10th day of June 2010, at the Session Hall of the Municipal Building, Taytay, Rizal.


