WHEREAS, his dedication and commitment as a legislator and public servant have contributed astoundingly in the upliftment of effective governance in our locality;


WHEREAS, the untimely death of a dignified great man, a humble yet highly principled legislator have left a stature in the legislative body worth inspiring;
