REQUESTING THE LOCAL CHIEF EXECUTIVE, HON. GEORGE RICARDO R. GACULA II TO APPROPRIATE THE AMOUNT OF EIGHTY ONE THOUSAND NINE HUNDRED FIFTEEN PESOS (P81,915.00) FOR THE CONSTRUCTION OF COMFORT ROOMS IN MUZON ELEMENTARY SCHOOL, BARANGAY MUZON, TO BE CHARGED UNDER THE TWENTY PERCENT DEVELOPMENT FUND

WHEREAS, Education is one of the main priorities of the Local Government;

WHEREAS, the main purpose of this resolution is to make the comfort rooms more accessible and convenient for the students and teachers;

Gacula II to appropriate the amount of Eighty One Thousand Nine Hundred Fifteen Pesos (P81,915.00) for the construction of comfort rooms in Muzon Elementary School, Barangay Muzon to be charged under the Twenty Percent Development Fund;


RESOLVED FURTHER, that copy of this Resolution be furnished to all concerned for their information and appropriate action;
