WHEREAS, the Sangguniang Bayan decided to extend financial incentives to the Athlete through the Aid to Sangguniang Kabataan Fund;



ADOPTED, this 10<sup>th</sup> day of November, 2010 at the Session Hall of the Municipal Building.


