RESOLUTION NO. 99

REQUESTING THE OFFICE OF THE HONORABLE CONGRESSMAN JOEL ROY R. DUAVIT TO INITIATE A MOVE TO CONVENE THE TASK FORCE FOR UPDATES AND APPROPRIATE ACTIONS AND ALSO TO SUPPORT TO DEFER THE FORMULATION AND IMPLEMENTATION OF A COMPREHENSIVE REHABILITATION PLAN FOR THE LUPANG ARENDA, MANGGAHAN FLOODWAY, NAPINDAN CHANNEL

WHEREAS, Proclamation No. 458 was earlier issued dated August 29, 1994 “Reserving for Socialized Housing Development certain Parcels of Land situated along Manggahan Floodway in the Municipalities of Cainta and Taytay, Province of Rizal and the Municipality of Pasig, Metro Manila, Transferring to the National Housing Authority the Ownership of said Government Lands and declaring the same open for disposition in favor of the qualified beneficiaries pursuant to Republic Act No. 7279 and Memorandum Order No. 191 dated February 12, 1994;

WHEREAS, Proclamation no 704 was also issued by then President Fidel V. Ramos dated November 28, 1995 setting aside a portion of the public domain located at Sitio Tapayan, Barangay Sta. Ana, Taytay Rizal for socialized housing development in favor of Pasig River squatters and less privileged families of Taytay, with National Housing Authority as administrator;

WHEREAS, Proclamation No. 1160 was later issued dated October 17, 2006 amending Proclamation No. 458, dated August 29, 1994 reserving twenty parcels of land at Manggahan and its allied structures for the construction of Medium-rise socialized and low-cost housing project landless-homeless employees of the Provincial Government of Rizal;

WHEREAS, last December 4, 2009 Executive Order #854 was issued by Her Excellency President Gloria Macapagal Arroyo "Revoking Presidential Proclamation No. 704, s. 1995 and Implement a Comprehensive Rehabilitation Plan for the Napindan Channel, Lupang Arenda and Manggahan Floodway";

WHEREAS, the above mentioned EO-854 was believed to be hastily signed by President Arroyo without sufficient technical evaluation and proper consultation with the stakeholders;

WHEREAS, a task force was created by virtue of EO-854 with the Department of Public Works and Highways as the lead agency to formulate and implement a two-year Comprehensive Rehabilitation Plan for the Napindan Channel as well as the areas covered by PP # 704 and PP 1160 of which the LGU of Taytay is one of the Ten (10) designated members. Twice the task force was convened beginning last July 2010 but our LGU was not duly informed or invited to participate in any of those two (2) meetings;

WHEREAS, last month of October 2010, the Municipality of Taytay Rizal took the initiative to invite the different agencies and groups to get updates on the above issue but the task force Chair-DPWH and Vice Chair-MMDA and LLDA were no shows;

WHEREAS, now we see this necessity of seeking the intercession of the office of the Honorable Congressman of the 1st District of Rizal in convening the different agencies concerned with this EO-854, to give us an accurate and relevant information on the status of the Executive Order and also to assist us in the move to defer the implementation of the proclamation;

WHEREAS, there had been several SB Resolutions passed previously which strongly opposed Executive Order #854 and strongly favor the non-implementation of Presidential Proclamation but instead are for the reversal of the proclamation and the executive order;

WHEREAS, no specific personalities are designated as representatives of the Taytay Municipal Government to sit as members of the Task Force it is recommended that the major stakeholders of Lupang Arenda and Manggahan Floodway be properly represented in the discussions by the task force;

WHEREAS, the issues about the EO-854, PP-704, PP-1160 & PP-458 greatly affect a big area of our jurisdiction and the lives of almost 100,000 families and make them worry so much;

NOW THEREFORE, BE IT RESOLVED, that the Sangguniang Bayan hereby requests the Office of the Honorable Congressman Joel Roy R. Duavit to initiate the move to convene the Task Force for updates and appropriate actions and also to support to defer the implementation of the comprehensive rehabilitation plan for the Lupang Arenda Manggahan Floodway & Napindan Channel;

RESOLVED FURTHER, to send copies of this Resolution to all persons concerned for their information and appropriate action.

ADOPTED, this 8th day of December 2010, at the Session Hall of the Municipal Building, Taytay, Rizal.
