WHEREAS, Montevista Heights Homeowners Association, Inc. has filed application for the alteration of plan of their existing residential subdivisions with corresponding Board Resolution;

WHEREAS, the lot affected by the proposed alteration of existing plan covers an open space consisting of 2,572 sq.m. and covered by TCT No. 561023 and now being proposed to be converted from its current use as open space to commercial purposes;

WHEREAS, in order not to reduce the amenities of the subdivision, the homeowners association shall make provisions for the replacement of the open space to be altered in accordance with the provision of PD 957;


WHEREAS, the proposed alteration of plans shall comply with the applicable provisions of existing laws and rules and regulations of the Housing and Land Use Regulatory Board;


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
