RESOLUTION NO. 2

**ADOPTING PROVINCIAL ORDINANCE NO. 017 SERIES OF 2010,
"AN ORDINANCE GRANTING REAL PROPERTY TAX
AMNESTY TO OWNERS/ADMINISTRATORS OF REAL
PROPERTIES IN THE PROVINCE OF RIZAL WHOSE REAL
PROPERTY TAXES, INCLUDING BUILDINGS, IMPROVEMENTS, MACHINERIES
AND EQUIPMENT THEREON ARE DELINQUENT
IN THE PAYMENT OF REAL PROPERTY TAXES**

WHEREAS, the Sangguniang Panlalawigan of Rizal recently enacted Provincial Ordinance No. 017 series of 2010 which states "An Ordinance granting Real Property Tax Amnesty to Owners/Administrators of Real Properties in the Province of Rizal whose Real Property Taxes, including Buildings, Improvements, Machineries and Equipment thereon are Delinquent in the Payment of Real Property Taxes;

WHEREAS, the Sangguniang Bayan of Taytay recognizes the noble intention of Hon Governor Casimiro "Jun" Ynares and the Sangguniang Panlalawigan of Rizal in granting Real Property Tax Amnesty to delinquent real property owners;

WHEREAS, condoning the collection of surcharges interest and penalties imposed upon delinquent real property owners in the Municipality of Taytay would alleviate the financial burden of our constituents affected by the economic crisis in the past few years;

WHEREAS, granting tax relief to delinquent real property owners in the Municipality of Taytay would result to an increased real property tax collection as real property owners are given the opportunity to avail of the 100% condonation on surcharges, interest and penalties of their delinquent real properties;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN OF TAYTAY, IN SESSION DULY ASSEMBLED, hereby adopts Provincial Ordinance No. 017 series of 2010, "An Ordinance granting Real Property Tax Amnesty to Owners/Administrator of Real Properties in the Province of Rizal whose Real Property Taxes, including Building, Improvements, Machineries and Equipment thereon are Delinquent in the Payment of Real Property Taxes";

RESOLVED FURTHER, that the Municipal Assessor, Municipal Treasurer and Municipal Legal Office with the approval of the Municipal Mayor, Hon. George Ricardo R. Gacula II, shall promulgate rules and regulations for the implementation of the tax amnesty ordinance:

RESOLVED FURTHERMORE, that copies of this resolution be furnished to all concerned for their information and appropriate action.
