RESOLUTION NO. 10

ESTABLISHING A SISTERHOOD RELATIONSHIP WITH THE CITY OF VERNON, LOS ANGELES CALIFORNIA IN THE UNITED STATES OF AMERICA AND THEREBY AUTHORIZING THE MUNICIPAL MAYOR, HON. GEORGE RICARDO R. GACULA II TO NEGOTIATE AND ENTER INTO THE MEMORANDUM OF AGREEMENT FOR THE PURPOSE

WHEREAS, Section 33 of the Local Government Code of 1991 states that, "*xxx Local Government Units may group themselves, considerate or coordinate their efforts, services and resources for purposes commonly beneficial to them xxx*";

WHEREAS, the City of Vernon, California, USA has observed the Municipality of Taytay, in Rizal Province, Philippines in the field of public service and economic growth;

WHEREAS, the municipality has common grounds with the City of Vernon, California, USA in achieving its desires towards excellence and good governance;

WHEREAS, establishing bilateral cooperation with the said city will be beneficial to both local government units in implementing programs on socio-economic development, tourism, trade and investment, public service, among others;

WHEREAS, the Memorandum of Agreement shall be ratified by the Sangguniang Bayan before its full implementation;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved the Sangguniang Bayan of Taytay, Rizal, Philippines duly assembled in session, hereby authorizes the Municipal Mayor, Hon. George Ricardo R. Gacula II to negotiate and enter into a Memorandum of Agreement to establish a sisterhood relationship with the City of Vernon, California, USA;

RESOLVED FURTHER, that copy of its Resolution be furnished to the City of Vernon, California, USA and all concerned for their information and appropriate action;

ADOPTED, this 2nd day of February 2011, at the Session Hall of the Municipal Building, Taytay, Rizal.
