NAMING THE TAYTAY NATIONAL HIGH SCHOOL (SIMONA EXTENSION) AT BARANGAY SAN ISIDRO AS SIMONA NATIONAL HIGH SCHOOL

WHEREAS, the primary objective of the Local Government Unit is to provide basic services and to ensure quality education among our constituents;

WHEREAS, the Local Government Code of 1991, the functions of Local School Board Sec. 99 letter D states that the Local School Board shall recommend changes in the names of Public Schools within the territorial jurisdiction of the Local Government Unit as enacted by the Sangguniang concerned;

WHEREAS, Municipal School Board had passed a Resolution No. 12 Series of 2011 purposely to make Taytay National High School (Simona Extension) independent from the existing Taytay National High School;

WHEREAS, the Sangguniang Barangay of San Isidro issued a certification dated January 18, 2011 allowing the Taytay National High School (Simona Extension) named as Simona National High School;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan duly assembled in session, hereby names Taytay National High School (Simona Extension) at Barangay San Isidro as Simona National High School;
