URGING THE MUNICIPAL GOVERNMENT OF TAYTAY FOR STRICT COMPLIANCE TO DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) MEMORANDUM CIRCULAR #2011-08 ENTITLED STRICT ADHERENCE TO SECTION 90 OF REPUBLIC ACT 10147, GENERAL APPROPRIATION ACT, THE USE AND DISBURSEMENT OF INTERNAL REVENUE ALLOTMENT AND MEMORANDUM CIRCULAR 2010-83 ENTITLED FULL DISCLOSURE OF LOCAL BUDGET AND FINANCES, BIDS AND PUBLIC HEARING

WHEREAS, the circular aims to recognize the peoples participation in governance by giving them a chance to participate and have access on the information of government transactions;

WEHEREAS, the said circular states to have full disclosure of several government reports such as, Annual Budget, Quarterly Statement of Cash Flows, Statement of Receipts and Expenditures, Trust Fund Utilization, Quarterly Utilization of Special Education Fund 20% Component of the IRA Utilization, Annual Gender and Development (GAD) Accomplishment, Statement of Debt Service, Annual Procurement Plan, Items to Bid through Electronic Procurement System (EPS), Bid Results on Civil Works and Good and Services including EPS and Abstract of Bid as Calculated;

WHEREAS, for public awareness the said reports must be posted in public places bulletin board, newsletter or websites for proper information dissemination;

WHEREAS, the Sangguniang Bayan of Taytay finds the resolution worth recognizing in the spirit of transparency and good governance;

NOW THEREFORE RESOLVED, as it is hereby resolved by the Sangguniang Bayan in session hereby recommends to the Local Chief Executive, Hon. George Ricardo R. Gacula II to impose strict compliance of Memorandum Circular #2011-08;
