REQUESTING HON. JOEL ROY DUAVIT, REPRESENTATIVE, FIRST DISTRICT OF RIZAL TO PRIORITIZE THE ALLOCATION OF FUND FOR THE COMPLETION AND WIDENING OF ILOG PUGAD BRIDGE IN BARANGAY SAN JUAN AND TOMAS MAG-ATAS BRIDGE IN BARANGAY MUZON

WHEREAS, the traffic situation along Manila East Road will be getting worse especially during the opening of Puregold (Taytay);

WHEREAS, the completion of the road widening and drainage improvement will ease the traffic and intensify our campaign for a continuous and better services to our constituents

WHEREAS, in line with the drainage improvement it will be better to include in the project the possibility of improving the river and water ways;

WHEREAS, re-routing of passenger jeepneys inside El Monteverde Subdivision will stop as it causes a lot of irritations from the residences of the said subdivision;

WHEREAS, motorists and commuters traversing Tomas Mag-atas Bridge in Barangay Muzon suffers from heavy traffic due to the narrowness of the said bridge;
