
RESOLUTION NO. 50

**REQUESTING HIS EXCELLENCY BENIGNO S. AQUINO III,
PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES TO RENDER
FAVORABLE RESPONSE TO THE RECOMMENDATIONS OF THE
TECHNICAL WORKING GROUP (TWG) ON THE REVIEW OF THE
EXECUTIVE ORDER NO. 854 SUBMITTED BY DILG SECRETARY
JESSE ROBREDO**

WHEREAS, the residents of Lupang Arenda and Manggahan Floodway have requested President Benigno S. Aquino III to conduct review of Executive Order No. 854

WHEREAS, President Aquino approved the conduct of review of Executive Order No. 854 thru the creation of a Technical Working Group (TWG) headed by DILG Secretary Jesse Robredo;

WHEREAS, the Technical Working Group have finished the review and submitted recommendations to the Office of the President on March 15, 2011;

WHEREAS, a favorable response to the recommendation submitted by the Technical Working Group by the President would be advantageous and beneficial to the security of tenure of the qualified present-occupants of Lupang Arenda and Manggahan floodway;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan duly assembled in session, hereby requests His Excellency Benigno S. Aquino III, President of the Republic of the Philippines to render favorable response to the recommendations of the Technical Working Group (TWG) on the review of the Executive Order No. 854 submitted by DILG Secretary Jesse Robredo.
