WHEREAS, DPWH-First District of Rizal has come up with an Approved Detailed Estimate and Program of Works for the Proposed Construction of Pedestrian Overpass in front of Golden City Subdivision and that this has been submitted to the Office of Congressman Joel Duavit for funding consideration/outsourcing;
