### RESOLUTION NO. 94

#### **URGING THE LOCAL CHIEF EXECUTIVE, HON. GEORGE RICARDO R. GACULA II, FOR THE IMPLEMENTATION OF EXECUTIVE ORDER NO. 841, THRU THE MUNICIPAL DEVELOPMENT COUNCIL, THIS MUNICIPALITY**

WHEREAS, Executive Order No. 841 "Directs all Local Chief Executives and Local Development Councils to immediately revisit/reformulate/formulate their respective comprehensive land use plans, identifying for the purpose the areas for socialized housing and resettlement/relocation, further directing the Housing and Urban Development Coordinating Council (HUDCC) to facilitate the inventory of government-owned lands suitable for socialized housing purposes";

WHEREAS, Our Municipal Development Council is composed of the Local Chief Executive as the Chairman, our Congressman, the Chairman of the Committee on Appropriations of our Sangguniang Bayan, the five (5) Punong Barangays of our municipality, two (2) representatives from Non-governmental Organization/People's Organization as members and our Municipal Planning and Development Coordinators (MPDO) as the Secretariat;

WHEREAS, Section 9, Article XII of the Constitution mandates that the State shall, in cooperation with the private sector, undertake a continuing program of urban land reform and housing which will make available, at affordable cost, decent housing and basic services to underprivileged and homeless citizens in urban centers and resettlement areas;
