RESOLUTION NO. 5

GRANTING EXTENSION FOR THE PAYMENT OF REGISTRATION OF RENEWAL OF BUSINESS PERMIT AND LICENSES UP TO FEBRUARY 3, 2012 WITHOUT PENALTIES AND SURCHARGES

WHEREAS, payment of Business Permit and Licenses has been stalled due to the requirements being imposed on the Professional Tax Receipt that no Business Permit and Licenses shall be issued without registration from the Department of Trade and Industry;

WHEREAS, due to the economic crises besetting our country and the financial difficulties felt by most businesses, taxpayers must be given ample time for the settlement of their Business Permit and License to avoid necessary charges and penalties;

WHEREAS, it would be best to extend the payment of registration and renewal of Business Permit and License up to February 3, 2012;

WHEREAS, the Sangguniang Bayan had required all concern departments and sections in the filing of Business Permit to provide a system of procedure in the implementation of the processing of payment for the convenience of the paying public;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, the Sangguniang Bayan in session hereby extends the payment of Registration of Renewal of Business Permit and License up to February 3, 2012 without penalties and surcharges;


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action;
