**RESOLUTION NO. 17**

**AUTHORIZING THE MUNICIPAL MAYOR, HON. GEORGE RICARDO R. GACULA II, TO ACCEPT THE DONATION OF A PARCEL OF LAND, CLASSIFIED AS ROAD LOTS, BY JUANITO DELA PAZ, AVELINA DELA PAZ, LEONORA DELA PAZ AND DANILO DELA PAZ, ALL HEIRS OF DELFIN DELA PAZ, CONSISTING OF ONE THOUSAND FIVE HUNDRED (1,500) SQUARE METERS, MORE OR LESS, LOCATED AT BUKAL II, BARANGAY DOLORES, TAYTAY, RIZAL, IN FAVOR OF THE MUNICIPALITY**

WHEREAS, the heirs of Delfin dela Paz, thru a letter dated March 20 2011, have manifested their willingness to donate the road lots within their residential property located at Bukal II, Brgy. Dolores, Taytay, Rizal;

WHEREAS, the road lost being donated consisting of one thousand five hundred (1,500) sq.m. more or less, is part of a bigger parcel of land as shown by a survey plan approved in 1967, under PSU-234318;

WHEREAS, the donation of the said road lots to the Municipality would facilitate the delivery of services within the community and to ensure its maintenance and development;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the Sangguniang Bayan, in session duly assembled, hereby authorizes the Municipal Mayor, Hon. George Ricardo R. Gacula II, to accept the donation of a parcel of land, classified as road lots, by the heirs of Dela Paz, consisting of one thousand five hundred (1,500) square meters, more or less, and located at Bukal II, Barangay Dolores, Taytay, Rizal, in favor of the Municipality.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.


