AMENDING RESOLUTION NO. 77 SERIES OF 2011

RECOMMENDING TO THE LOCAL CHIEF EXECUTIVE, HON. GEORGE RICARDO R. GACULA II, TO EARMARK AND CHARGE THE AMOUNT OF THIRTY-EIGHT THOUSAND, SIX HUNDRED FORTY PESOS (P38,640.00) FOR THE TRANSFER OF ACCOUNT OF SEVEN (7) STREETLIGHTS FROM THE HOMEOWNERS OF PHASE 1, CIUDAD GRANDE SUBDIVISION, BRGY. MUZON, TAYTAY, RIZAL TO THE MUNICIPALITY OF TAYTAY, FOR FISCAL YEAR 2012

WHEREAS, it is stated in Resolution No. 77 S. 2011 that the residents of Phase 1, Ciudad Grande Subdivision are requesting for installation of seven (7) streetlights;

WHEREAS, there is a need to amend Resolution No. 77 S.2011 as per requirement imposed by MERALCO, since the electric connection exist already in the area the word installation is not appropriate purpose thereby amending the resolution;

WHEREAS, let the title of the said resolutions be amended to and be stated as: "A resolution recommending to the Local Chief Executive, Hon. George Ricardo R. Gacula II, to earmark and to charge the amount of Thirty-Eight Thousand, Six Hundred Forty Pesos (P38, 640.00) for the transfer of account of seven (7) streetlights from the homeowners of Phase 1, Ciudad Grande Subdivision, Brgy. Muzon, Taytay, Rizal, to the Municipality of Taytay, for the Fiscal year 2012;
