**RESOLUTION NO.66**

**APPROVING THE LIST OF ANTI-POVERTY REDUCTION PROJECT OF THE  
MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, Executive Order No. 43, S.2011 dated 13<sup>th</sup> of May 2011 mandated the organization into cluster and shall serve as the primary mechanism of the Executive Branch towards the realization of the Social Contract with the Filipino People;

WHEREAS, the Human Development and Poverty Reduction Cluster (HDPRC) is tasked to improved the overall quality of life Filipino and translating the gains on good governance into direct, substantial benefits that will empower the poor marginalized segment of the society;

WHEREAS, the Local Government Code (LGC) of 1991 mandate community to participate in local development councils and various organized local special bodies, such as, local school and health boards, and local development council, among others;

WHEREAS, the National Government Agencies and other stakeholder shall pursue the Millennium Development Goal of reducing poverty from 26.5% in 2009 to 16.6. by 2015;

WHEREAS, the Department of Budget and Management (DBM), the Development of Interior and Local Government (DILG), the Department of Social Welfare and Development

(DSWD) and the National Anti-Poverty Commission (NAPC) are piloting the bottom-up approach in planning budgeting and ensures the inclusion of the founding requirement for the development need of at least 300 of the 609 focus local government units (LGU) as identified and approved by the HDPRC;

WHEREAS, the LGU organized reactivated the expanded Local Poverty Reduction Action Team (LPRAT), chaired by the Local Chief Executive and composed of the chairperson of the Sangguniang Bayan Appropriation Committee, the Planning Officer, Agriculture Officer, Social Welfare and Development Officer, Budget Officer, Liga ng mga Barangay, Local Government Operation Officers, DSWD Municipal Links ,a Pantawid Parent-Leader, a Community Health Team Leader, LGU accredited CSOs, NGA accredited/recognized CSO's NAPC identified basic sector representative;

WHEREAS, the LPRAT conducted a workshop to formulate a local Poverty Reduction Action (LPRAT) Plan indicating therein unfunded priority anti-poverty projects;

WHEREAS, the LPRAT has prepared the list of priority projects for 2013 based on the LPRAP for allocation of budget from national government agencies and other financial institution for 2013;

WHEREAS, the list of priority was duly endorsed by the partner of CSO representatives as proof genuine participation in identifying the priority projects;

NOW THEREFORE ,RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Taytay hereby approves the list of Anti-Poverty Reduction Projects in the Municipality of Taytay;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
