**APPROPRIATING THE AMOUNT OF FIVE THOUSAND FIVE
HUNDRED TWENTY PESOS (P5, 520.00) FOR THE INSTALLATION OF
ONE (1) STREETLIGHT LOCATED AT CORTEZ ST., BARANGAY
DOLORES, TAYTAY, RIZAL**

WHEREAS, the residents of Cortez Street in Barangay Dolores have requested for installation of streetlight in their area;

WHEREAS, the paramount concern of this resolution is for the safety and convenience of the residents of the said area;

WHEREAS, the Engineering Department has already inspected and submitted their recommendation for new feasible streetlights;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved that the Sangguniang Bayan duly assembled in session hereby appropriates the amount of Five Thousand, Five Hundred Twenty Pesos (P5,520.00) for the installation of one (1) streetlight located at Cortez Street, Barangay Dolores, Taytay, Rizal, to be charged under the Illumination Fund;
