**RESOLUTION NO. 73**

**APPROVING IN REVIEW THE ANNUAL BUDGET FY 2012,

IN THE AMOUNT OF TWENTY TWO MILLION, FOUR

NOW THEREFORE, be it resolved, as it is hereby resolved, by the Sangguniang Bayan in session duly assembled, to hereby approves in review the Annual Budget FY 2012, of Barangay Sta. Ana, as contained in its Appropriation Ordinance No. 2012-001, in the amount of Twenty Two Million Four Hundred Seventeen Thousand Eight Hundred Eighty Pesos (PHP. 22,417,880.00) subject to compliance with the conditions stated in the review evaluation, evaluation and recommendation report made by the Municipal Budget Officer dated March 26, 2012;

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.


