CONSTRUCTION OF CONCRETE OVERLAY AT HIGHWAY 2000 PHASE I,

WHEREAS, Highway 2000 Phase 1, Barangay San Juan, Taytay, Rizal, has been heavily damage due to flooding during rainy seasons and passage of heavy vehicles, which make it difficult for commuters and vehicles to traverse the said road;

WHEREAS, such inconvenience cause delays, not only affecting the social movement of the population, but also the local economy and business of the surrounding areas;


RESOLVED FURTHER, that copy of this Resolution be furnished to all concerned for their information and appropriate action.
