RESOLUTION NO. 97

**GRANTING THE APPLICATION FOR DEVELOPMENT
PERMIT OF STA. LUCIA LAND INCORPORATED, FOR
THE PROPOSED ADDITIONAL PHASE OF ITS RESIDENTIAL
SUBDIVISION PROJECT, NAMED "GREENWOODS EXECUTIVE
VILLAGE PHASE 9-E", LOCATED AT BARANGAY STA. ANA,
TAYTAY, RIZAL**

WHEREAS, Sta. Lucia Land Incorporated, has applied for development permit to its proposed subdivision project, named "Greenwoods Executive Village Phase 9-E", situated at Barangay Sta. Ana, Taytay, Rizal;

WHEREAS, the total land area applied for development in this subdivision project consists of 7,314 square meters and covered by Transfer of Title No's. 068-2012000318, 068-2012000319, 698284 and 724816;

WHEREAS, the developer shall make provisions to, and to undertake the rip-rapping of all legal easement of drainage of waters including those extremely slanted areas, and all existing waterways be maintained;

WHEREAS, the Municipal Planning and Development Office of the municipality has submitted all the pertinent documents and issued a Certificate for the Development Plans and other requirements attesting that all were in conformity with the standards promulgated by the Housing and Land Use Regulatory Board (HLURB);

WHEREAS, the Engineering Department and the Municipal Planning and Development Office shall monitor the development of the said subdivision up to the completion of the project;

WHEREAS, all legal easements existing within and abutting the property to be developer shall be maintained and respected: and the three meters easement on both sides of the legal easement of drainage of waters shall be cemented by the developer;

WHEREAS, the pertinent provisions of PD 957 and its implementing rules and regulations, as well as existing barangay and municipal ordinance and resolutions on the matter shall be strictly followed by the applicant/developer;

WHEREAS, non-compliance or violation of any of the conditions above indicated, or any misrepresentation and/or materials falsehood on the part of the developer is a sufficient cause for the cancellation/revocation of this Development Permit;


WHEREAS, base on Ordinance No. 15, Series of 2008, the Material Recovery Facility (MRF) is a requirement in the development of subdivision;

NOW THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Bayan in session duly assembled, hereby grants the application for Development Permit of Sta. Lucia Land Incorporated, for the proposed additional phase of its residential subdivision project, named "Greenwoods Executive Phase 9-E", and located at Barangay Sta. Ana, Taytay, Rizal;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concern for their information and appropriate action;

ADOPTED, this 9th day of August, 2012 at the Session Hall of the Municipal Building, Taytay, Rizal.


