WHEREAS, the area to be illuminated is located at the corner of Gomez Street and Manila East Road;

WHEREAS, it is important to illuminate the said area because of the big volume of vehicles and pedestrians that passes the area daily;

WHEREAS, the Engineering Department has already inspected the area and submitted the list of feasible streetlights;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan duly assembled in session hereby appropriates the amount of Eleven Thousand and Forty Pesos (P11,040.00) for the Installation of two (2) Streetlights located at Gomez Street corner Manila East Road, Barangay San Juan, Taytay, Rizal;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action;
