R. GACULA II FOR THE STRICT IMPLEMENTATION OF DEPARTMENT OF
INTERIOR AND LOCAL GOVERNMENT (DILG) MEMORANDUM
CIRCULAR NO. 2011-17**

WHEREAS, the Department of Interior and Local Government (DILG) Memorandum Circular No. 2011-17 calls on all local government units (LGUs) to adopt measures to effectively curtail the proliferation of informal settlers and mendicants in their respective localities;

WHEREAS, several Barangay Governments in the Municipality of Taytay had already adopted necessary measures and actions to implement Memorandum Circular No. 2011-17;

WHEREAS, the unison in all LGU levels for the strict implementation of Memorandum Circular No. 2011-17 plays the key role-in-achieving its objectives;

WHEREAS, the Local Chief Executive is in the best position to lead in setting the appropriate example for the strict implementation of the DILG Memorandum;

WHEREAS, the Sangguniang Bayan would like also to inquire on the status of the implementation of the said Memorandum Circular and request a written status report from the office/offices assigned to by the Local Chief Executive;

NOW, THEREFORE, BE IT RESOLVED as it is hereby resolved, requesting the Local Chief Executive Hon. George Ricardo R. Gacula II for the strict implementation of Department of Interior and Local Government Memorandum Circular No. 2011-17.
