EARNESTLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HON. JANET DE LEON-MERCADO, TO ALLOCATE FUNDS IN THE AMOUNT OF FOUR HUNDRED TWENTY THREE THOUSAND FIVE HUNDRED FORTY ONE PESOS AND FIFTEEN CENTAVOS (PHP 423,541.15) FOR THE CONCRETING OF TAPAYAN ELEMENTARY SCHOOL GROUNDS TO BE CHARGED UNDER THE 20% DEVELOPMENT FUND, THIS MUNICIPALITY

WHEREAS, fulfilling the education-related Millennium Development Goals (MDGs) requires not just getting all children into school, but making sure that all schools work in the best interest of the children;

WHEREAS, providing safe and appropriate facilities are foremost if we are to create a healthy, child-friendly learning environment, including but not limited to concreting of school grounds;

WHEREAS, concreting of school grounds can be used for sports, outdoor learning activities, play area and extra-curricular activities which helps in child learning and development;


WHEREAS, concreting of school grounds at Tapayan Elementary School would require a total amount of Four Hundred Twenty Three Thousand Five Hundred Forty One Pesos and Fifteen Centavos (Php 423,541.15);

WHEREFORE, BE IT RESOLVED, as it is hereby resolved by the 9th Sangguniang Bayan of Taytay, Rizal, in Session duly assembled, hereby requests the Local Chief Executive, Hon. Janet de Leon-Mercado, to allocate funds in the amount of Four Hundred Twenty Three Thousand Five Hundred Forty One Pesos and Fifteen Centavos (Php 423,541.15) for the concreting of Tapayan Elementary School Grounds to be charged under the 20% Development Fund, this municipality;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerns for their information and appropriate action;
