WHEREAS the late Honorable June V. Zapanta is well -loved and respected and will always be remembered not only by his family and friends but the whole municipality as well;


WHEREAS, the entire Municipality of Taytay and its people join his family and relatives in the outpouring of support and grief for the eternal repose of his soul;



ADOPTED, this 14th day of September 2013 at the Sangguniang Bayan Session Hall Municipality of Taytay, Province of Rizal.


