WHEREAS, an adequate funding is required for the drainage system within the Public Market Area to contain the volume of water flowing in and out of the facility;

WHEREAS, the existing shallow, narrow and heavily zilted drainage system on site already create bottle neck and clogging scenario in this area of concern;

WHEREAS, the improvement and orderliness on the physical presentability in the appearance of the market facility shall foster a new customer-friendly looks;


WHEREAS, after due observation and assessment on this area of responsibility based on the ocular inspections, this income generating market facility needs remedial measures that requires adequate funding allocation;
