WHEREAS, as per 9th Sangguniang Bayan Resolution No. 20 series of 2013”
Authorizing Municipal Mayor Hon. Janet DL. Mercado to Negotiate and enter into a
Memorandum of Agreement with National Food Authority (NFA) Represented by its
Provincial Manager Armando Ray C. Villacorta ;

WHEREAS, the National Food Authority program stated in MOA will provide a
chance for the Municipal Government of Taytay to purchase rice (on credit) for its relief
operation whenever a state of calamity is declared;

agencies and offices devolved to them;


WHEREAS, provinces, cities, municipalities in particular have been tasked with


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
