Cooperative TAFECO (2nd party) and Technical Education and Skills Development Authority TESDA (3rd Party);


WHEREAS, the parties had agreed on the stated purpose in the Memorandum of Agreement;


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
